How to complete this application form

This application form and any supporting information provided with it are for a Trainee Licence to Handle Controlled Substances under the *Ozone Layer Protection Act No. 22 of 2019* (the OLP Act) and the Ozone Layer Protection Regulation (the OLP Regulation). Refrigeration and air conditioning technicians require a Licence to Handle Controlled Substances or a Trainee Licence to Handle Controlled Substances.

The OLP Act and OLP Regulation give effect to Vanuatu's obligations under the Vienna Convention for the Protection of the Ozone Layer and the Montreal Protocol on Substances that Deplete the Ozone Layer and regulate controlled substances and manufactured products.

Controlled substances are gases listed in the Montreal Protocol and the Schedule of the OLP Act. You can find a copy of the schedule on our website: www.environment.gov.vu.

Manufactured products are any of the following products that contain or are designed to use a controlled substance: dry-cleaning machines; fire extinguishers; automobile and truck air conditioning units; marine transportation and refrigeration; and domestic, commercial and industrial refrigerators, freezers, chillers, dehumidifiers, water coolers, ice machines, display cabinets, cold storage systems, air conditioning and heat pump units and any other refrigeration and air conditioning or heat pump equipment.

If you undertake any of the following activities (or other activities that involve a risk of a controlled substances being emitted into the atmosphere), you must apply for a Licence to Handle Controlled Substances or a Trainee Licence to Handle Controlled Substances:

1. **Recover** a controlled substance. That is, collect and store controlled substances from manufactured products, machinery, equipment and containment vessels during servicing or prior to disposal.
2. **Recycle** a controlled substance. That is, re-use a recovered controlled substance following a basic cleaning process such as filtering and drying.
3. **Reclaim** a controlled substance. That is, re-process and upgrade a recovered controlled substance through such mechanisms as filtering, drying, distillation and chemical treatment in order to restore the controlled substance to a specified standard of performance which often involves processing 'off-site' at a central facility.
4. **Install, service, recharge, repair or decommission a manufactured product.**

Only individual persons may hold a Licence to Handle Controlled Substances or Trainee Licence to Handle Controlled Substances and the granting of a licence depends on your qualifications and experience. This form is designed to help you show us that you have the qualifications and experience to safely and responsibly handle controlled substances. If you cannot respond to the questions in this application form, you may not be eligible to hold a Trainee Licence to Handle Controlled Substances.

NOTE: holders of a Trainee Licence to Handle Controlled Substances must work under the supervision of a person with a Licence to Handle Controlled Substances.

Your application will not be considered unless you return this form, completed and signed; include all relevant attachments; and pay the application fee. **Please attach a passport size photo to your application.**

Payment of application fees: applications for a Trainee Licence to Handle Controlled Substances require payment of a 3,000 vatu application fee (excluding VAT). This fee is provided for in the OLP Regulations.

Application fees must be paid at the government cashier at the Department of Finance and Treasury. We do not accept payments at our offices. Please take the attached invoice to the government cashier for payment. **A receipt from the government cashier must be attached to this application form** when it is submitted to the Department. Your application will not be processed until you provide us with a copy of the receipt from the government cashier.

YOU MUST NOT HANDLE CONTROLLED SUBSTANCES UNLESS AND UNTIL YOU HAVE BEEN GRANTED A LICENCE TO HANDLE CONTROLLED SUBSTANCES OR TRAINEE LICENCE TO HANDLE CONTROLLED SUBSTANCES BY THE DEPARTMENT

1. You are enrolled in an accredited course that, upon completion, entitles you to be awarded at least a Certificate IV in refrigeration and air conditioning from a registered provider approved to deliver the accredited course in which you are enrolled: OR
2. You are enrolled in that, upon completion, entitles you to be awarded at least a Certificate III in refrigeration and air conditioning from an overseas registered provider or accredited institution recognised by the Vanuatu Qualifications Authority; OR
3. You have at least one years' experience in the refrigeration and air conditioning industry and have completed the Good Practices in Refrigeration course (or equivalent qualification recognised by the Director).

To assess your application, we need to understand the ground you are using as the basis for your application and you need to provide proof that you satisfy this ground.
